

**Airly Promotion “PM Helium Sensors Presale 2020/2021”
Terms and Conditions**

§ 1 General Provisions

1. These terms and conditions constitute an appendix to Airly Sensors Terms of Sale and the terms written in capital letters should be understood accordingly, subject to the provisions of paragraph 2 below.
2. In these terms and conditions the following terms, which are written in capital letters, shall be understood as follows:
 - a. **“Discount Code”** - special code indicating the amount of discount for PM Helium Sensors under promotion, made available by Airly in the Platform, Map, Airly’s mobile application and social media, enabling the Client participation in the promotion;
 - b. **“Final Delivery Date”** - the date specified in these terms and conditions, to which Airly is obliged to deliver the PM Helium Sensor to the Client;
 - c. **“PM Helium Sensor”** - the PM Helium Sensor, offered in this presale promotion, specified by Airly in the Platform;
 - d. **“Promotion Period”** - period of time specified in these terms and conditions, in which the promotion is made available to the Client.
3. Under this promotion, the Client is able to place the presale order through the Platform prior to the placing on the market of the PM Helium Sensor.
4. The goal of this promotion is to acquaint the Client with Airly’s offer regarding sale of the PM Helium Sensors through the Platform.
5. Under this promotion, Airly is obliged to sell and the Client is obliged to purchase the PM Helium Sensor under these terms and conditions.
6. The promotion applies only to the presale of PM Helium Sensors sold by Airly through the Platform.
7. The promotion is organized by Airly.

§ 2 Legal basis of the promotion

1. The legal basis of this promotion constitutes these terms and conditions which are also the only document specifying the detailed principles of this promotion.
2. In matters not covered with these terms and conditions, the provisions of the Airly Sensors Terms of Sale and General Terms of Service are applicable.
3. Only the Client who purchases the PM Helium Sensor during the Promotion Period, using the Discount Code can participate in this promotion.

§ 3 Promotion Period

1. The promotion applies to the orders placed between **December 19th, 2020 00:01 GMT and January 31st, 2021 7:00 GMT (Promotion Period)**.
2. The decisive date for participation in the promotion is the date of the order placement.
3. The promotion ends on the expiry of the Promotion Period.

§ 4 PM Helium Sensor Delivery

1. Under this promotion, the Final Delivery Date of the PM Helium Sensor to the Client is **31st May, 2021**.
2. If the order has not been delivered to the Client by the Final Delivery Date, the Client has the right to withdraw from the agreement or agree on a new delivery date with Airly.

§ 5 Promotion principles

1. The amount of the discount granted to the Client is each time dependent on the value of the discount assigned to the Discount Code.
2. The amount of the discount granted to the Client indicated in the Discount Code refers to the

gross standard price indicated in the Pricing.

3. The amount of PM Helium Sensors available for purchase under this promotion is not limited in quantity.
4. The promotion applies to all territories where PM Helium Sensors are available to purchase through the Platform.

§ 6 Final provisions

1. These Terms of Service enter into force on 19/12/ 2020.
2. Participation in the promotion is voluntary.
